- I. Additions to Agenda

- II. Minutes of Previous Meeting

## III. Reports

1. President's Message

Safety and security is a major concern, and we should have regular fire drills. Judith would serve as fire marshall. Fire evacuation routes are posted Keys to the office have been ordered and would be given to those who need them, and one will be kept in the AED box. Harbor Freight Tool as large, fire-proof safe that could be used to secure important papers. People who took the CPR course will receive certificates. Items for Lost and Found have been placed in a box in the office. The box could be put out every Sunday, and items should be donated after some time.

2. Treasurer's Report

The Finance Committee wants to be able to move encumbered funds, but it requires a congregational vote to move encumbered funds to unencumbered.

## IV. Unfinished Business

- Pressure Tank for Irrigation System The Grounds committee found that the irrigation system overheats the pressure switch, which uses more power and will eventually cause the pump to overheat. Pipes and switches also may need to be replaced. Bree and Gordon Dinmore will install the pump; the total cost should be about \$300. They will use money in the Grounds budget and will ask for additional funds later if needed.
- 2. Long Range Plan Preparation

Linda Myers couldn't find the Long Range Plan that was developed under John Springer. We need to form a committee, and Linda Myers will write an announcement for Sunday asking for members. There have been 3-year evaluations. Linda will ask Stan Brumaghim for the last report. Joan Burnett indicated that she would like to be on the committee. MOTION by Ellen Saunders, second by Linda Myers, that we form an ad-hoc committee to create a long-range strategic plan for this Fellowship. Passed unanimously.

3. Computer Skills

Ellen Saunders would like the P&P Manual to reflect that officers and directors need to have computer skills. Sheila Woods and Ellen Saunders would help, and there are courses at the libraries. Judith Englert helps our President monitor email including documents.

4. Fall Concert

The new insurance policy is in effect, for planning for the concert can proceed. There was discussion about the date, and it was decided that there will be two performances, Friday evening, 16 November, and Saturday afternoon, 17 November. The Concert Committee would like an advance of \$250. The drummer would be paid at the end of the 2<sup>nd</sup> concert.
